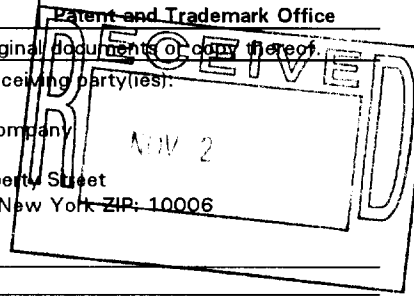

**ASSIGNMENT FOR
SECURITY IN U.S. TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, each Domestic Subsidiary of Coltec Industries whose name appears on the signature pages to the Security Agreement referred to below (each an "Assignor" and collectively, the "ASSIGNORS"), hereby assigns and grants to BANKERS TRUST COMPANY ("Assignee"), with principal offices at One Bankers Trust Plaza, New York, New York 10006, as Administrative Agent for the benefit of the Secured Creditors (as defined in the Security Agreement referred to below), a security interest in, *inter alia*, all of the right, title and interest of each of the Assignors in and to the U.S. trademarks and trademark applications set forth on Schedule A hereto (the "Trademarks") under their respective names, together with all Proceeds (as such term is defined in the Security Agreement) and products of said Trademarks, the goodwill of the businesses symbolized by said Trademarks, and the right (but not the obligation) to sue for past, present and future infringements of such Trademarks.

This Assignment is made to secure the satisfactory performance of all of the Obligations, as such term is defined in that certain Security Agreement dated as of December 18, 1996, as the same may be amended, modified or supplemented from time to time (the "Security Agreement") among Assignee and each of the Assignors. If the Security Agreement shall terminate in accordance with its terms, the Assignee shall, at the request and expense of each of the Assignors, upon such termination, execute and deliver to each Assignor a proper instrument or instruments releasing the security interest in the Trademarks acquired under this Assignment.
