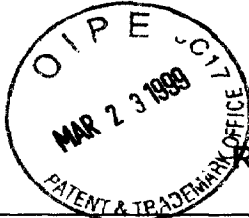

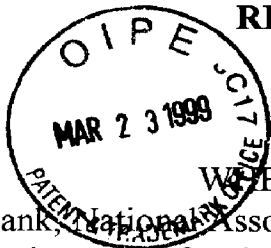

RELEASE OF SECURITY INTEREST - TRADEMARKS
