NOTICE OF RELINQUISHMENT OF
TRADEMARK SECURITY INTEREST

This NOTICE OF RELINQUISHMENT OF TRADEMARK SECURITY INTEREST is executed as of October 15, 1997 by Morgan Guaranty Trust Company of New York, as Agent for the Lenders (as defined below) (the "Agent"), with reference to that certain Credit Agreement dated as of July 10, 1997 (the "Credit Agreement") among Orion Pictures Corporation, a Delaware Corporation (the "Company"), the lenders referred to therein (the "Lenders") and the Agent.

Pursuant to the Credit Agreement and the Borrower and Guarantor Security Agreement dated as of July 10, 1997 (the "Security Agreement") among the Company, certain of its material subsidiaries listed on Schedule 1 hereto (the "Subsidiaries") and the Agent, the Company and each of the Subsidiaries executed and delivered to the Agent the Trademark Security Agreement dated as of July 10, 1997, which was filed with the United States Patent and Trademark Office and recorded at Reel 1621, Frame 322, et seq. as of August 13, 1997 (the "Trademark Security Agreement").

For good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby:

- (a) terminates the Trademark Security Agreement;
- (b) releases the liens and security interests granted to it pursuant to the Security Agreement or the Trademark Security Agreement in the Trademark


Collateral as defined in the Trademark Security Agreement, including but not limited to each Trademark registration and Trademark application, and all of the goodwill associated therewith, listed on Schedule 2 attached hereto; and

- (c) to the extent the Agent shall be deemed to have any right, title or interest in the Trademark Collateral pursuant to the Security Agreement or the Trademark Security Agreement, retransfers and reassigns to the Company all of such right, title and interest.

This Notice of Relinquishment Of Trademark Security Interest shall be governed by the laws of the State of New York and shall relate solely to the Security Agreement and the Trademark Security Agreement and shall in no way be construed as relating to any other interest in the Trademark Collateral which the Agent may have.
