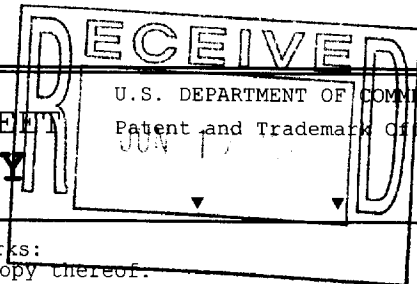

RELEASE OF SECURITY INTERESTS -- TRADEMARKS

This Release of Security Interests -- Trademarks (the "**Release**") is made by PNC Bank, National Association (the "**Bank**"), a national banking association with its principal place of business at One PNC Plaza, 249 Fifth Avenue, Pittsburgh, Pennsylvania, 15222-2707.

W I T N E S S E T H:

WHEREAS, the Bank and CQ, Inc. ("**CQ**") a Delaware corporation with its principal place at One Quality Center, Homer City, Pennsylvania 15748, are parties to that certain Agreement Regarding Loans dated as of October 31, 1997, as amended by that First Amendment to Agreement Regarding Loans, dated as of January 23, 1998 ("**First Amendment**"), and by that Second Amendment to Agreement Regarding Loans, dated as of April 1, 1998 ("**Second Amendment**"), and by that Third Amendment to Agreement Regarding Loans, dated as of September 22, 1998 ("**Third Amendment**") and by that Fourth Amendment to Agreement Regarding Loans, dated as of November, 1998 ("**Fourth Amendment**") (the Agreement Regarding Loans, as amended by the First Amendment, Second Amendment, and Third Amendment, as amended, restated, supplemented or replaced from time to time, shall be referred to as the "**Agreement**");

WHEREAS, pursuant to the Agreement, CQ executed and delivered to the Bank a Security Agreement dated November 21, 1997 (the "**Security Agreement**") and a Rider to Security Agreement - Trademarks dated November 21, 1997 (the "**Trademark Rider**");

WHEREAS, the Trademark Rider was recorded on December 9, 1997, at Reel 1665, Frame 0309 in the United States Patent and Trademark Office (the "**Office**");

WHEREAS, in the Security Agreement and the Trademark Rider, CQ assigned to PNC and pledged and granted a lien and security interest to PNC in, inter alia, trademarks of CQ, including without limitation, the trademarks shown on Exhibit "A" attached hereto, and all rights related thereto in order to secure the satisfaction of the Bank Indebtedness (as such term is defined in the Agreement);

WHEREAS, the portions of the Bank Indebtedness has been repaid and CQ has agreed to provide the Bank with certain substitute collateral and the Bank now desires to release its rights created by the Security Agreement and the Trademark Rider;

WHEREAS, the attached Exhibit "A" identifies all the specific trademarks included in the Security Agreement;

WHEREAS, PNC has not granted any license, right or privilege with respect to any of the trademarks which were the subject of the Security Agreement, and has not encumbered such rights in any other way.


NOW, THEREFORE, for valuable consideration, receipt of which is hereby acknowledged, PNC does hereby release, cancel and annul its entire right and interest in such trademarks created by the Security Agreement, as referenced in the attached Exhibit

"A" and the assignments of such trademarks are hereby defeased, and the rights granted thereunder shall be deemed returned to and revested in CQ.

This Release shall not be construed as a satisfaction of any debts and obligations of CQ to the Bank, nor shall this Release affect any other lien against any other property of CQ in favor of the Bank.
