

PARTIAL RELEASE OF COLLATERAL ASSIGNMENT OF
TRADEMARKS AS SECURITY

WHEREAS, pursuant to that certain Collateral Assignment of Trademarks as Security dated as of December 20, 1996 from HENRY COMPANY, a corporation organized and existing under the laws of the State of California (the "Pledgor") in favor of NATIONSBANK, N.A., a national banking association, now known as Bank of America, N.A., (the "Lender"), and filed with the United States Patent and Trademark office on March 20, 1998 at Reel 1707, Frame 0762 of the Trademark Record (the "Security Document"), the Lender became the holder of a security interest in and to all of the right, title and interest in, under or by virtue of certain trademarks, trademark applications, licenses and other intangible assets owned by the Pledgor and more particularly described in the Security Document (the "Collateral"); and






