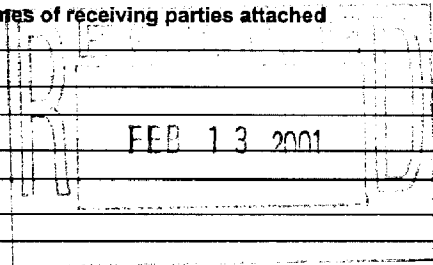

## POSTPETITION TRADEMARK SECURITY AGREEMENT

**THIS POSTPETITION TRADEMARK SECURITY AGREEMENT** (as amended, supplemented or otherwise modified from time to time, this "Agreement") is made and entered into as of January 22, 2001, by CONVERSE INC., a Delaware corporation and a debtor and a debtor-in-possession in a case under Chapter 11 of the Bankruptcy Code (the "Borrower") in favor of BANKERS TRUST COMPANY, as agent (the "Agent") for the Lenders (as defined below) under the Credit Agreement (as defined below).

### RECITALS:

**WHEREAS**, on January 22, 2001 (the "Filing Date"), the Borrower filed a voluntary petition with the Bankruptcy Court initiating the Case and has continued in the possession of its assets and in the management of its business pursuant to Sections 1107 and 1108 of the Bankruptcy Code.

**WHEREAS**, an immediate and on-going need exists for the Borrower to continue to obtain additional funds in order to continue the operation of its business as debtor in possession under Chapter 11 of the Bankruptcy Code, and accordingly the Borrower, the Agent, as agent for itself and the other financial institutions party thereto, the Lenders and the Agent have entered into that certain Postpetition Credit Agreement dated as of January 22, 2001 (as amended, restated, modified or supplemented from time to time, the "Credit Agreement") and into the Credit Documents executed and delivered in connection therewith (together with the Credit Agreement, the "Postpetition Credit Documents").

**WHEREAS**, the Borrower has applied to the Lenders for a revolving credit, letter of credit and acceptance facility in an aggregate principal amount not to exceed \$68,785,306.

**WHEREAS**, the Lenders are willing to continue to provide the requested financial accommodations to the Borrower under the Credit Agreement and other Credit Documents upon the condition, among others, that the Borrower enter into this Agreement.

**WHEREAS**, pursuant to the Credit Agreement and the Postpetition Credit documents executed and delivered in connection therewith, the Lenders propose to make certain credit facilities available to the Borrower (the "Loans"); and

**WHEREAS**, as a condition to the Lenders making the Loans available to the Borrower, the Agent, as agent for itself and the other Lenders, has required that the Borrower execute that certain Postpetition Security Agreement dated as of January 22, 2001, by and between the Borrower and the Agent (the "Security Agreement") in which the Borrower has, among other things, granted to the Agent a security interest in the Intellectual Property (as defined in the Security Agreement) including a security interest in the trademarks and service marks and trademark and service mark applications listed on Schedule I attached hereto, and the goodwill of the businesses symbolized by or connected therewith (collectively, the "Trademark Collateral"), to secure the payment of all amounts owing under the Obligations;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Borrower and Agent agree as follows:

1. Borrower hereby grants to the Agent for the benefit of the Agent and the Lenders a continuing security interest in all of the Borrower's right, title and interest in and to the Trademark Collateral whether now owned or hereafter acquired, including all income, royalties, damages and payments now or hereafter due or payable with respect thereto including, without limitation, damages and payments for past or future infringement and rights to royalties under licenses of and consents relating to any of the foregoing, and all rights (but not obligations) corresponding thereto in the United States and any foreign country, and any goodwill associated with any of the foregoing. Borrower hereby further acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral are more fully set forth in the Postpetition Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

2. Upon the occurrence of an Event of Default (as defined in the Credit Agreement), the Borrower shall, in connection with any disposition of collateral that includes goodwill associated with the Trademark Collateral, execute and deliver to the Agent an Assignment of Trademark Registrations and Applications substantially in the form attached as Exhibit A hereto. If the Borrower fails to provide such document within ten days after it has been requested by the Agent, then the Agent may complete such document by exercise of a power of attorney hereby granted by the Borrower. Such power of attorney is coupled with an interest and is irrevocable.

3. All notices, demands, consents, statements, requests, approvals or other communications which are permitted or required to be given by either party to the other

hereunder shall be in writing and shall be given as provided in Section 13.5 of the Credit Agreement.

4. This Agreement cannot be modified, changed or discharged except by an agreement in writing signed by the Borrower and the Agent.

5. This Agreement shall be construed and enforced in accordance with the internal laws of the State of New York.

6. This Agreement is subject in all respects to the Postpetition Security Agreement, the terms of which are incorporated herein by this reference.

7. The security interests created hereunder and under the Postpetition Security Agreement in the Trademark Collateral shall cease and be released in accordance with the terms of the Postpetition Security Agreement and the Credit Agreement.

8. The terms defined in the Credit Agreement or Postpetition Security Agreement and not otherwise defined herein shall have the respective meanings provided for therein unless the context otherwise requires. If any provision hereof conflicts with any provision of the Credit Agreement or the Postpetition Security Agreement, the terms of the Credit Agreement or Postpetition Security Agreement shall control to the extent of such inconsistency.
