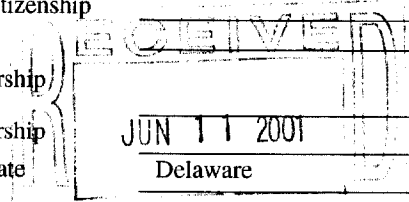

Getronics Acquisition, Inc. ("Getronics Acquisition"), a corporation organized and existing under the laws of Delaware, DOES HEREBY CERTIFY pursuant to Section 253 of the General Corporation Law of the State of Delaware (the "DGCL"):

FIRST: That Getronics Acquisition was incorporated on the thirtieth day of April, 1999, pursuant to the DGCL.

SECOND: That Getronics Acquisition owns (i) at least ninety percent of the outstanding shares of common stock, par value \$0.01 per share, including the associated rights (the "Common Stock"), of Wang Laboratories, Inc. ("Wang"), a corporation incorporated on the sixteenth day of December, 1993, pursuant to the DGCL, (ii) all of the outstanding shares of 4 1/2% Series A Cumulative Convertible Preferred Stock, par value \$0.01 per share (the "Series A Preferred Stock"), of Wang, (iii) at least ninety percent of the outstanding depository shares (the "Depository Shares"), each representing a 1/20th interest in a share of 6 1/2% Series B Cumulative Convertible Preferred Stock, par value \$0.01 per share (the "Series B Preferred Stock"), of Wang, which together represent at least ninety percent of the outstanding shares of the Series B Preferred Stock, and that no other class of capital stock is currently issued and outstanding.
