TRADEMARK ASSIGNMENT



This Assignment is effective as of the date hereof. Assignor agrees to sign any additional Assignments and other appropriate documentation necessary to effectuate and validate this Assignment under the relevant laws or regulations of the countries set forth in Schedule A, as soon as practicable after the date of this Assignment.


