ASSIGNMENT OF SECURITY INTEREST (PATENTS AND TRADEMARKS)

Reference is made to each of the following:

(a) the Intellectual Property Security Agreement, dated as of May 2, 1995, made by PAGING NETWORK, INC., a Delaware corporation (the "Debtor"), in favor of BANK OF AMERICA, N.A. (successor in interest to NATIONSBANK OF TEXAS, N.A.), as Documentation Agent (the "Existing PageNet Documentation Agent"), and the other Secured Parties party thereto (the "Existing PageNet Secured Parties") (as amended through November 10, 2000, the "Existing Intellectual Property Security Agreement"); and

(b) the Notice of Security Interest in Trademarks, executed by the Debtor and Existing PageNet Documentation Agent pursuant to the Existing Intellectual Property Security Agreement (the "Notice of Security Interest in Trademarks").

WHEREAS, the Debtor entered into the Existing Intellectual Property Security Agreement and the Notice of Security Interest in Trademarks, to secure the payment of obligations of the Debtor to the Existing PageNet Documentation Agent and the Existing PageNet Secured Parties;

WHEREAS, an executed copy of the Existing Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on Reel 1394 and Frame 0594, on September 8, 1995;

WHEREAS, an executed copy of the Notice of Security Interest in Trademarks was recorded in the United States Patent and Trademark Office on Reel 2028 and Frame 0764, on March 2, 2000; and

WHEREAS, the Existing PageNet Documentation Agent has assigned its rights under the Existing Intellectual Property Security Agreement to The Bank of New York, as Collateral Agent (the "Collateral Agent"), under and pursuant to (a) the Amended and Restated PageNet Intellectual Property Security Agreement, dated as of November 10, 2000, made by the Debtor in favor of the Collateral Agent and (b) the Joinder and Assumption Agreement, dated as of November 10, 2000, by and among Arch Wireless Holdings, Inc., the Debtor, each subsidiary of the Debtor listed on Schedule I thereto, the Existing PageNet Documentation Agent, each of the Existing PageNet Secured Parties and The Bank of New York, as Administrative Agent, under the Third Amended and Restated Credit Agreement, dated as of March 23, 2000, by and among Arch Wireless Holdings, Inc. (formerly, Arch Paging, Inc.), the lenders party thereto and the Agents party thereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Existing PageNet Documentation Agent hereby:

(a) Assigns to the Collateral Agent any and all liens, security interests, right, title and interest of the Existing PageNet Documentation Agent pursuant to the Existing Intellectual Property Security Agreement and the Notice of Security

Interest in Trademarks in the patents, trademarks and other items which are described more fully on Exhibit A attached hereto, without recourse or representation or warranty, express or implied; and

(b) Authorizes and requests the United States Patent and Trademark Office to note and record the existence of the assignment hereby given.

IN WITNESS WHEREOF, the Existing PageNet Documentation Agent has caused this Assignment to be signed by its duly authorized officer as of the 10th day of November, 2000.
