REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of September 18, 2002 by PNC BANK, NATIONAL ASSOCIATION (the "BANK") to SYNXIS CORPORATION, a Delaware corporation with its principal place of business at 7926 Jones Branch Drive Ste. 1000, McLean, VA 22102 (the "BORROWER").

Recital


