**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Dayton Superior Specialty Chemical Corp., a Kansas corporation (the "Grantor") with principal offices at 4226 Kansas Avenue, Kansas City, KS 66106, hereby assigns and grants to Bankers Trust Company, as Collateral Agent, with principal offices at 130 Liberty Street, New York, New York 10006 (the "Grantee"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademark SNAPLUGS, Registration Number 899,048, Registration Date Sept. 22, 1970, (the "Mark"), (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Mark, (iii) the goodwill of the businesses with which the Mark is associated and (iv) all causes of action arising prior to or after the date hereof for infringement of the Mark or unfair competition regarding the same.

THIS GRANT is made to secure the satisfactory performance and payment of all the Obligations of the Grantor, as such term is defined in the Security Agreement among the Grantor, the other assignors from time to time party thereto and the Grantee, dated as of June 16, 2000 (as amended from time to time, the "Security Agreement"). Upon the occurrence of the Termination Date (as defined in the Security Agreement), the Grantee shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks acquired under this Grant.


