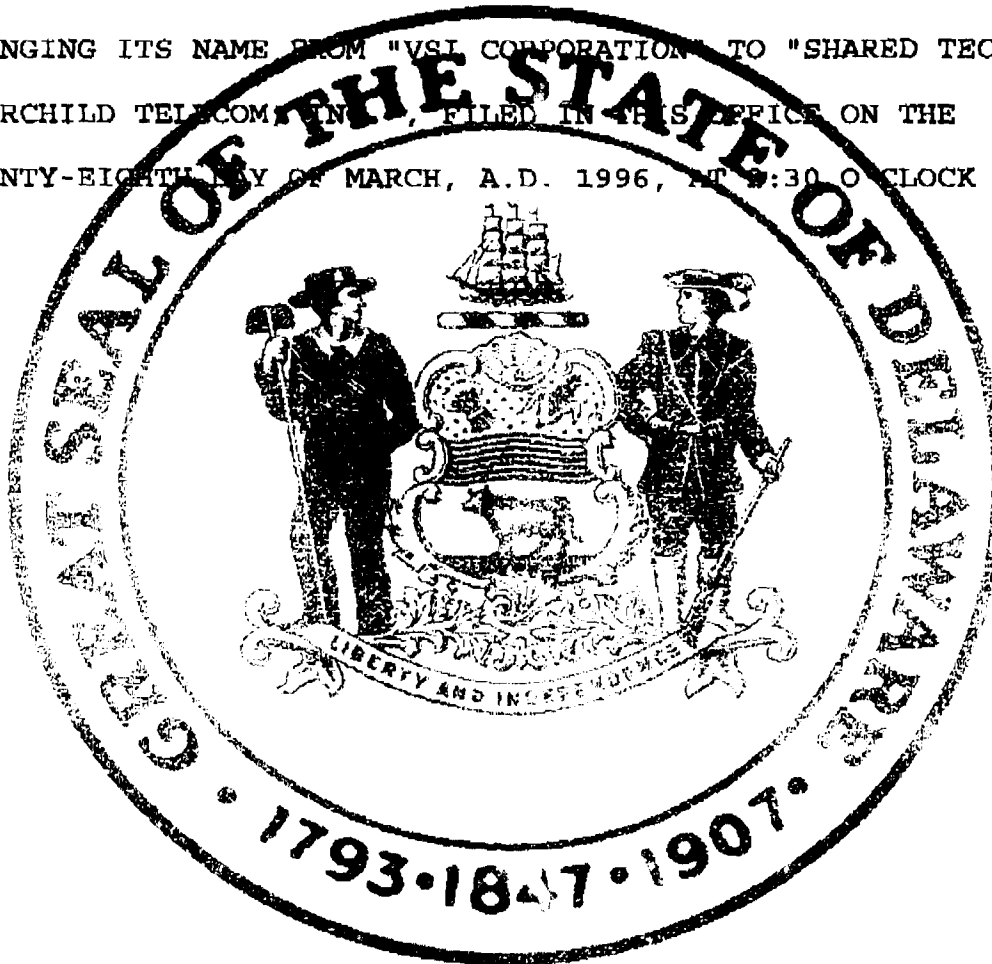

1. The name of the corporation (hereinafter called the "corporation") is VSI Corporation.


2. The certificate of incorporation of the corporation is hereby amended by striking out Article First thereof and by substituting in lieu of said Article the following new Article:
