RELEASE OF SECURITY INTEREST AND ASSIGNMENT

THIS RELEASE OF SECURITY INTEREST AND ASSIGNMENT (this "Release and Assignment") is given as of this 10 day of October, 2002 by PNC Bank, National Association, as agent for the Lenders ("Secured Party") to Rocky Mountain Holdings, L.L.C., a Delaware limited liability company (the "Debtor").

BACKGROUND

A. Debtor and Secured Party entered into a Collateral Assignment of Patents, Trademarks, Licenses and Copyrights dated as of May 7, 1999 ("Agreement"), pursuant to which Debtor granted and assigned to Secured Party a security interest in Debtor's Patents, Trademarks, Licenses, Copyrights and goodwill (the "Collateral").

B. The Obligations (as defined in the Agreement) having therefore been fully satisfied and discharged, the parties wish to evidence the termination of the Agreement, release of the associated security interest in the Collateral and assign all rights, title and interests in and to the Collateral to Debtor.


RELEASE AND ASSIGNMENT

The Debtor is hereby authorized to file this Release and Assignment and any other instruments with the PTO to evidence the same.
