WHEREAS, the Pledgors have entered into a Security Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), dated as of June 25, 2003, in which each Pledgor has agreed with Wachovia Bank, National Association, as Agent (the "Agent"), with offices at One Wachovia Center, 301 South College Street, Charlotte, North Carolina 28288-0735, to execute this Collateral Assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Secured Obligations (as defined in the Security Agreement), each Pledgor does hereby collaterally assign and grant to the Agent a security interest in all of its right, title and interest in and to the Trademarks and the Patents, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks and the Patents. This Collateral Assignment has been given in conjunction with the assignment and security interest granted to the Agent under, and subject to the terms and conditions of, the Security Agreement, and the provisions of this Collateral Assignment are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.


