**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of March 23, 2005, from JPMorgan Chase Bank, N.A. (formerly JPMorgan Chase Bank formerly known as The Chase Manhattan Bank), as Administrative Agent (the "Administrative Agent") for certain banks and other financial institutions (the "Lenders"), to Solucient, LLC, a Delaware limited liability company (the "Company") located at 1007 Church Street, Suite 700, Evanston, Illinois 60201 and HBS International, Inc., a Washington corporation, located at 1007 Church Street, Suite 700, Evanston, Illinois 60201, ("HBS" and together with the Company, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement dated as of November 24, 1999, in favor of the Agent (the "Security Agreement"), a security interest (the "Company Granted Security Interest") was granted by the Company to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, in connection with the Security Agreement, HBS entered an assumption agreement, dated as of December 4, 2000 (the "Assumption Agreement"), which made HBS a party to the Security Agreement and granted a security interest (the "HBS Granted Security Interest", together with the Company Granted Security Interest, the "Security Interest") to the Administrative Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 6, 2001, at Reel 002274 and Frame 0298; the Assumption Agreement was recorded on March 27, 2001, at Reel 002267 and Frame 0718, and the supplement to the Security Agreement was recorded on November 13, 2002, at Reel 002615 and Frame 0527; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this termination and release, the Administrative Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Security Agreement.


2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or

interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
