**CONFIRMATORY GRANT OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

THIS CONFIRMATORY GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Security Agreement") is made effective as of April 11, 2005 by and from SUZO INTERNATIONAL (NEDERLAND) B.V. (the "Grantor"), a private limited liability company organized under the laws of the Netherlands, with a principal business address of Antonie van Leeuwenhoekstraat 9, 3261 LT, Oud-Beijerland, the Netherlands, to and in favor of JPMORGAN CHASE BANK, N.A., as administrative agent (the "Grantee").

WHEREAS, Grantor and Grantee have entered into a Pledge Agreement of Intellectual Property Rights dated March 22, 2005 ("Pledge Agreement").

WHEREAS, the Grantor owns the rights to intellectual property ("IP Rights") as provided in the Pledge Agreement, including, without limitation, the IP Rights which are listed on Exhibit A attached hereto, which IP Rights are used, issued, registered or pending in the United States Patent and Trademark Office and registries worldwide.

WHEREAS, this Security Agreement has been granted in conjunction with the Pledge Agreement between Grantor and Grantee, which Pledge Agreement was given to secure obligations owed by Grantor to Grantee under that certain Credit Agreement which is dated December 22, 2004 ("Credit Agreement"). The rights and remedies of Grantee with respect to the security interest granted herein are without prejudice to those set forth in the Pledge Agreement and the Credit Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Security Agreement are deemed to conflict with the Pledge Agreement or Credit Agreement, the provisions of the Pledge Agreement shall govern.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Pledge Agreement.

2) The Security Interest.

(a) This Grant is made to secure the satisfactory performance and payment of all the Obligations of Grantor under the Credit Agreement and the Pledge Agreement. Upon the payment in full of all Obligations (other than contingent indemnification obligations), Grantee shall promptly, upon such satisfaction, execute, acknowledge, and deliver to Grantor all reasonably requested instruments in writing releasing the security interest in the IP Rights acquired under this Security Agreement.

(b) The Grantor hereby grants to Grantee a security interest in all of Grantor's right, title and interest in and to the IP Rights including, without limitation, the IP Rights set forth in Exhibit A, now owned or from time to time after the date hereof owned or acquired by the Grantor.

IN WITNESS WHEREOF, the Grantor has executed this Grant of Security Interest effective as of the date first written above.
