## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE is given as of this 1<sup>st</sup> Day of February, 2005 by JPMorgan Chase Bank, N.A. **NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security interest in the Trademarks and reassigns any and all interest that it may have in the Trademarks to Assignee.

All capitalized terms used but not defined herein shall have the respective meanings ascribed to them in the Security Agreement.

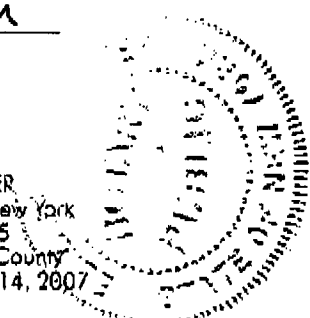
