RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of April 21, 2005 is given by JPMORGAN CHASE BANK, N.A., f/k/a JPMORGAN CHASE BANK (f/k/a The Chase Manhattan Bank), as administrative, documentation, syndication and collateral agent for certain lenders, with a place of business at One Chase Square, CS-5, Rochester, New York 14643 (hereinafter "JPMorgan Chase Bank") to COMPUTER TASK GROUP, INCORPORATED, a New York corporation, CTG SERVICES, INC., a New York corporation, COMPUTER TASK GROUP INTERNATIONAL, INC., a Delaware corporation, CTG HEALTHCARE SOLUTIONS, INC., a Delaware corporation and CTG HEALTHCARE SOLUTIONS (KANSAS), INC., a Kansas corporation, each with an office located at 800 Delaware Avenue, Buffalo, New York 14209 (hereinafter referred to collectively as "CTG"); and

WHEREAS, JPMorgan Chase Bank and CTG are parties to that certain Security Agreement dated as of May 11, 2001, and recorded in the United States Patent and Trademark Office at Reel 002343, Frame 0613 on August 2, 2001 (the "Security Agreement"); and

WHEREAS, pursuant to such Security Agreement, CTG, as security for indebtedness to JPMorgan Chase Bank, did grant to JPMorgan Chase Bank a security interest and lien in all of its right, title and interest in, to and under the trademarks referred to in Exhibit "A" attached hereto and hereby made a part hereof, including all trademarks (including service marks), federal and state trademark registrations and applications, and common law trademarks and trade names, including all applications and registrations associated therewith, along with any and all (1) renewals thereof, (2) income, royalties, damages and payments then and thereafter due and/or payable with respect thereto, including without limitation, damages, claims and payments for past or future infringements thereof, (3) rights to sue for past, present and future infringements thereof, and (4) foreign trademarks, trademark registrations, and trade name applications for any thereof and any other rights corresponding thereto throughout the world, (collectively, "Trademarks"); and

WHEREAS, such indebtedness has been paid in full and such security interest and lien are no longer required;

NOW, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, JPMorgan Chase Bank does hereby release its security interest in and lien on the Trademarks, and hereby transfers to CTG, without recourse, all of its right, title and interest in, to and under the Trademarks, including all common law marks, applications and registrations associated therewith, together with any goodwill associated therewith.


This Release shall be binding upon and inure to the benefit of JPMorgan Chase Bank and CTG and their respective successors and assigns.
