TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 10, 2005, is made by JPMorgan Chase Bank, N.A. (formerly known as JPMorgan Chase Bank and formerly known as The Chase Manhattan Bank), as Administrative Agent (the "Secured Party").

WHEREAS, pursuant to the Credit Agreement, dated as of October 28, 1997, the Master Security Agreement, dated as of October 28, 1997, the Master Guarantee, dated as of October 28, 1997, the First Amendment to the Credit Agreement, dated as of April 1, 1998, the Supplement to Master Security Agreement, dated as of June 15, 1998, and the Supplement to Master Guarantee, dated as of June 15, 1998 (as said agreements may have been amended, modified, extended, renewed, restated or replaced from time to time, collectively the "Loan Documents"), Caribiner International, Inc., a Delaware corporation, Caribiner, Inc., a New York corporation, Visual Action Holdings Inc., a Delaware corporation, Hospitality Resources Incorporated, an Illinois corporation, Sound & Stagecraft, Inc., an Illinois corporation, Audio Visual Headquarters Corporation, a California corporation, USAV, Inc., a Delaware corporation, and HRI, V.I., Inc., a Virgin Islands corporation (the "Grantors") granted to the Secured Party a security interest (the "Security Interest") in the Trademark Collateral (as hereinafter defined);

WHEREAS, the security interest granted to the Secured Party was recorded at the United States Patent and Trademark Office on September 4, 1998 at Reel 1784 and Frame 0781; and

WHEREAS, the Secured Party has agreed to terminate and release the entirety of its security interest in all of such Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Loan Documents, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Secured Party hereby states as follows:

1. Definitions. The term "Trademark Collateral", as used herein shall mean all of the Grantors' right, title and interest of every kind and nature in the Trademarks and all Intellectual Property (including, without limitation, those items listed on Schedule A attached hereto). The terms "Trademarks" and "Intellectual Property" shall have the meaning provided by reference in the Loan Documents.

2. Release of Security Interest. The Secured Party hereby terminates, releases and discharges its security interest in the Trademark Collateral, and any right, title or interest of the Secured Party in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

IN WITNESS WHEREOF, the Secured Party has caused this Termination of Security Interest in the Trademark Collateral to be duly executed as of the date first set forth above.
