RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is given on this 5
day of August 2005 by JPMorgan Chase Bank, N.A., ("JPMorgan Chase"), a National Association, to
Collect America, Ltd. ("Collect America"), a Delaware corporation, as follows:

WHEREAS, on April 26, 2005, Collect America and JPMorgan Chase entered into a Trademark
Security Agreement;

WHEREAS, pursuant to said Trademark Security Agreement, Collect America granted to
JPMorgan Chase, among other collateral, a continuing security interest in all of the Collect America's
right, title and interest, including goodwill, in, to and under the United States trademarks listed on the
attached Schedule A (the "Marks");

WHEREAS, said Trademark Security Agreement was recorded in the United States Patent &
Trademark Office on April 29, 2005 at reel 3087 and frame 0547; and

WHEREAS, JPMorgan Chase wishes to release its security interest in the Marks and retransfer
and reassign to Collect America without recourse all of Collect America's right, title and interest in and to
the Marks.

reassigns any and all right, title and interest it may have in and to the Marks without recourse to Collect
America.

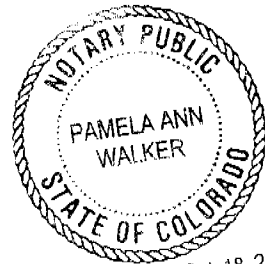
