RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of September 15th, 2005 ("Effective Date") in favor of F&W Publications, Inc., an Ohio corporation ("Grantor"), by JPMorgan Chase Bank, N.A., a national banking association ("Grantee").

WHEREAS, Grantor, Grantee and certain other parties named therein entered into a Guarantee and Collateral Agreement dated as of July 31, 2002 (the "Collateral Agreement"), pursuant to which the Grantor pledged and granted to the Grantee a continuing security interest in the Trademarks (as defined in the Collateral Agreement) and certain other intellectual property as security for certain loans and other extensions of credit made by the Lenders identified therein;

WHEREAS, in connection with entering into the Collateral Agreement, Grantor and Grantee entered into that certain Grant of Security Interest in Trademark Rights dated as of July 31, 2002 (the "Trademark Security Agreement"), pursuant to which Grantor granted Grantee a continuing security interest in the Trademarks including, without limitation, the United States trademark registrations and applications for trademark registration set forth on Schedule A attached hereto (collectively, the "Trademark Collateral") to secure payment, performance and observance of the Obligations (as defined in the Collateral Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on October 30, 2002, at Reel 2611, Frame 0929; and

WHEREAS, Grantor has paid, performed and observed all of its outstanding Obligations.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby (i) terminates the Trademark Security Agreement and (ii) terminates, cancels and releases any and all security interests it has against the Trademark Collateral and the goodwill associated therewith under the Trademark Security Agreement and the Collateral Agreement.
2. Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to any of the Trademark Collateral, other than the Trademark Collateral set forth on Schedule A (attached hereto), in any jurisdiction throughout the world.
3. Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other

instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

IN WITNESS WHEREOF, Grantee has caused this Release to be executed by its duly authorized representative as of the Effective Date.
