**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of August 5, 2005, is entered into by JPMORGAN CHASE BANK, N.A., a New York corporation, with a business address of 277 Park Avenue, 16<sup>th</sup> Floor, New York, New York 10172, as administrative agent ("Administrative Agent"), who is a party to that certain Credit Agreement, dated as of March 7, 2005, as Amended and Restated on July 18, 2005 (the "Credit Agreement") among the Lenders (as defined in the Credit Agreement), Administrative Agent and Jupitermedia Corporation (the "Borrower"). Any capitalized term used herein and not defined herein shall have the meaning assigned to it in the Credit Agreement.

**WITNESSETH**

WHEREAS, the Borrower is proposing to sell certain assets (the "Events Business Assets") of the Events Business pursuant to an Asset Purchase Agreement, dated as of August 2, 2005, between Incisive Media plc and the Borrower (the "Events Business Sale");

WHEREAS, the Borrower has requested that the Administrative Agent: (a) terminate and release the liens and interests of Administrative Agent in certain intellectual property included in the Events Business Assets; and (b) execute and deliver evidence of such termination and release for filing in the PTO;

WHEREAS, the grant of security interest pursuant to the Security Agreement in Trademarks and Trademark Licenses (as defined in the Security Agreement) that are set forth in Schedule A attached hereto, which are included in the Events Business Assets, was filed on behalf of the Administrative Agent, in the United States Patent and Trademark Office ("PTO") on April 7, 2005; and

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, having been duly authorized to do so on behalf of itself and the Lenders, hereby acknowledges and agrees as follows:

1. Acknowledgment of Termination of Grant of Security Interest in Trademarks. All rights and security interest in the Trademarks and Trademark Licenses (as defined in the Security Agreement) that are set forth in Schedule A attached hereto, which trademarks were included under the Grant of Security Interest, filed in the PTO on April 7, 2005, have been terminated and released and are no longer in force.




