TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Assignment") is made as of August 5, 2005 by and between Jupitermedia Corporation, a Delaware corporation, with its principal place of business located at 23 Old Kings Highway South, Darien, Connecticut 06820 ("Assignor"), and Incisive Media Plc, a limited company registered in England and Wales with its principal place of business at Haymarket House, 28-29 Haymarket, London, SW1Y 4RX, United Kingdom ("Assignee").

BACKGROUND

WHEREAS, the Assignor owns the trademarks and service marks, and the applications and registrations thereof, which are identified in Schedule A attached hereto (collectively, the "Trademarks");

WHEREAS, pursuant to the terms and conditions of the Asset Purchase Agreement, dated as of August 2, 2005, by and between Assignor and Assignee (the "Purchase Agreement"), Assignor is transferring the Purchased Assets, including all of the Assignor's right, title and interest in and to the Trademarks, whether registered or at common law, and the United States and foreign trademark applications and trademark registrations therefor, if any, together with all goodwill existing in connection with the Trademarks and symbolized by the Trademarks, to Assignee; and

WHEREAS, the parties wish to execute and deliver this Assignment for the purpose of assigning the Trademarks and all goodwill related to or symbolized by such Trademarks from Assignor to Assignee.

NOW, THEREFORE, to effect such transactions and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the parties agree as follows:

TERMS

1. Assignment. The Assignor hereby sells, conveys, transfers and assigns to the Assignee, and the Assignee hereby receives, acquires and accepts, all of the Assignor's right, title and interest in and to the Trademarks and the use thereof, as set forth in Schedule A, all past, present and future applications and registrations therefor and extensions and renewals thereof, together with all of the business associated with the Trademarks and all of the goodwill associated with or symbolized by the Trademarks, the right to sue for past, present and future infringement of the Trademarks and the right to any other claim arising out of or relating to the use and ownership of the Trademarks, and all rights corresponding with the foregoing throughout the world.

2. Rights Cumulative; Conflict With Purchase Agreement. The rights, duties and obligations of the parties hereunder shall be cumulative and in addition to the rights, duties and obligations of the parties under the Purchase Agreement. Nothing herein shall

be deemed to limit the rights, duties and obligations of the parties under the Purchase Agreement and, to the extent of any conflict between the terms and conditions of this Assignment and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall govern, supersede and prevail.

3. Further Assurances. The Assignor agrees to execute and deliver all such further transfers, assignments, conveyances and assurances as may reasonably be requested by the Assignee to obtain the full benefit of this Assignment, including, without limitation, in connection with the recordal of this Assignment in the United States and any non-U.S. jurisdiction.

4. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns. No party may assign either this Assignment or any of its rights, duties or obligations hereunder without the prior written approval of the other party; provided, however, that either party may (i) assign any or all of its rights hereunder to one or more of its Affiliates or any purchaser of all or substantially all of its assets or business or its capital stock (and, in the case of the Assignee, the SES Business), whether by merger or otherwise, and (ii) designate one or more of its Affiliates or other assignees to perform its duties or obligations hereunder (in any or all of which cases the assigning party nonetheless shall remain responsible for the performance of all of its duties or obligations hereunder in the event that assignee breaches this Assignment or fails to perform such duties or obligations).

5. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of New York without giving effect to any choice or conflict of law provision or rule (whether the State of New York or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of New York.

6. Counterparts. This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same agreement.

7. Definitions. Capitalized terms used but not defined herein shall have those meanings assigned to them in the Purchase Agreement.

8. Notices. All notices and other communications to be given under the terms of this Assignment or which any of the parties desire to give hereunder shall be in writing and shall be made in accordance with Section 11.07 (Notices) of the Purchase Agreement.
