**TRADEMARK SECURITY AGREEMENT
TERMINATION AND RELEASE**

This TERMINATION AND RELEASE (as amended, restated or otherwise modified from time to time, the "Termination and Release") is dated March 21, 2006 and made by JPMorgan Chase Bank, N.A. (successor by merger to JPMorgan Chase Bank, a New York banking corporation), as Administrative Agent (the "Administrative Agent") for the several banks and other financial institutions (the "Lenders"), in favor of Aftermarket Technology Corporation, a Delaware Corporation (the "Borrower"), parties to the credit agreement, dated as of February 8, 2002 (as amended, supplemented, or otherwise modified from time to time, the "Credit Agreement"), among the Borrower, the Lenders, the Administrative Agent, J.P. Morgan Securities Inc. and Credit Suisse First Boston ("CSFB") as Joint Advisors, Joint Lead Arrangers and Joint Bookrunners, and CSFB, as Syndication Agent. Capitalized terms not defined herein shall have the meanings ascribed to them in the Credit Agreement and the Guarantee and Collateral Agreement, which is defined below.

WITNESSETH

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Borrower has executed and delivered a Guarantee and Collateral Agreement, dated February 8, 2002, in favor of the Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Guarantee and Collateral Agreement");

WHEREAS, the Borrower and Lenders have agreed to terminate the Security Agreement and Guarantee and Collateral Agreement and release the continuing security interests in all Intellectual Property (as defined in the Guarantee and Collateral Agreement) and in the Trademarks (as defined in the Guarantee and Collateral Agreement), which the Borrower had previously pledged and granted to the Administrative Agent for the benefit of the Administrative Agent and the Lenders.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Borrower and Lenders hereby terminate and release the security interests in the trademarks and trademark applications listed on the attached Schedule A as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement and the Guarantee and Collateral Agreement.
2. Release of Security Interest. The Administrative Agent hereby terminates and

releases the continuing security interest in, right of setoff to, assignment of, transfer of, conveyance of, or any claim by the Lenders to the Trademarks (including, without limitation, those items listed on Schedule A hereto).

3. Purpose. This Termination and Release has been executed and delivered by the Borrower and Administrative Agent for the purpose of recording the release of the grant of security interest herein with the United States Patent and Trademark Office.

4. Counterparts. This Termination and Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
