**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby reassigns to Grantor all of its right, title and interest in and to the Released Trademarks and to the extent that the Agreement created a security interest in such Released Trademarks, Lender hereby releases such security interest.

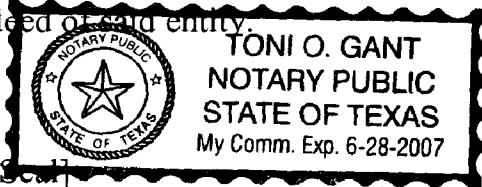
