TRADEMARK RELEASE, effective as of this 2nd day of May, 2006, given by JPMORGAN CHASE BANK, N.A. (f.k.a. 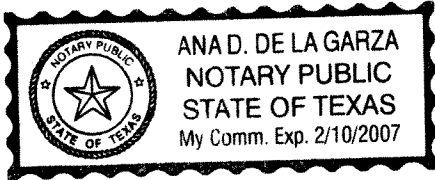
