**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of July 5, 2006, from JPMorgan Chase Bank, N.A. (f/k/a The Chase Manhattan Bank), a national banking association, as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to Activant Solutions Inc. (f/k/a Cooperative Computing, Inc. and Triad Systems Corporation), a Delaware corporation with its principal place of business located at 804 Las Cimas Parkway, Austin, Texas 78746.

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of February 27, 1997 (and as amended and restated as of February 10, 1998), made by the Grantors (as defined therein) in favor of the Agent (the "Collateral Agreement"), and the Conditional Assignment of and Security Interest in Trademark Rights, dated as of December 28, 1999, April 23, 2001, August 3, 2001, January 31, 2001 and June 11, 2002, made by Cooperative Computing, Inc. in favor of the Agent (the "Conditional Assignment Agreements"), a security interest (the "Security Interest") was granted to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Collateral Agreement was recorded in the United States Patent and Trademark Office on May 20, 1997 at Reel 1621 and Frame 0517, and April 9, 1998 at Reel 1711 and Frame 0105; and the Conditional Assignment Agreements were recorded in the United States Patent and Trademark Office on January 10, 2001 at Reel 2209 and Frame 0345, May 8, 2001 at Reel 2290 and Frame 0968, October 15, 2001 at Reel 2388 and Frame 0357, February 22, 2001 at Reel 2239 and Frame 0120, and July 24, 2002 at Reel 2548 and Frame 0885;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement and Conditional Assignment Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions: The term "Trademark Collateral," as used herein, shall mean all of the Grantors' and Activant Solutions Inc.'s right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Collateral Agreement.


2. Release of Security Interest: The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances: The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
