UNDER SECTION 1003 OF THE LIMITED LIABILITY COMPANY LAW

FIRST: The name and jurisdiction of formation or organization of each limited liability company or other business entity that is to merge is as follows:

Coty Cosmetics Inc.--New York  
Coty US LLC--Delaware

SECOND: As to each constituent domestic business corporation, the date that the initial certificate of incorporation was filed with the New York Department of State is as follows:

THIRD: As to each constituent foreign limited liability company, the jurisdiction and date that the original certificate of formation were filed and the date when its application for authority was filed by the New York Department of State is as follows:

FIFTH: The surviving foreign limited liability company may be served with process in this state in any action or special proceeding for the enforcement of any liability or obligation of any domestic business corporation previously amenable to suit in this state that is to merge and for the enforcement that is provided in the Business Corporation Law of the right of shareholders of any domestic business corporation to receive payment for their interests against the surviving foreign limited liability company/business entity.

SIXTH: The surviving foreign limited liability company hereby agrees that, subject to Section 1005 of the Limited Liability Company Law and/or Section 623 of the Business Corporation Law, that the surviving foreign limited liability company will promptly pay to the shareholders of each constituent domestic business corporation the amount, if any, to which they shall be entitled under the provisions of the Business

Corporation Law relating to the rights of shareholders to receive payment of their interests.

SEVENTH: The Secretary of State of the State of New York is designated as agent of the surviving foreign limited liability company upon whom process against it may be served. The post office address within or without this state to which the Secretary of State shall mail a copy of any process served upon him or her is 1325 Avenue of the Americas, New York, NY 10019, attn: General Counsel, Coty Inc.

EIGHTH: The merger is permitted by the laws of the jurisdiction of each constituent foreign limited liability company and is in compliance therewith. Each constituent foreign limited liability company has complied as follows: Coty US LLC has complied with the applicable provisions of the laws of the State of Delaware under which it is organized, and this merger is permitted by such laws.

NINTH: The agreement of merger is on file at the place of business of the surviving foreign limited liability company. The address of such foreign limited liability company is 1325 Avenue of the Americas, New York, NY 10019.

TENTH: A copy of the agreement of merger will be furnished by the surviving) foreign limited liability company on request and without cost to any member of any domestic business entity or to any person holding interest in any other business entity that is to merge.
