TRADEMARK ASSIGNMENT

WHEREAS, a written assignment of such Trademarks was not executed nor filed with the United States Patent and Trademark Office; and



NOW THEREFORE, for ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby confirm, *nunc pro tunc* that, as of March 28, 2006, it assigned to Assignee all its right, title and interest in and to the Trademarks, the common law rights pertaining thereto and all goodwill associated therewith including all the business to which the Trademarks pertain and the right to recover damages and profits and all other remedies for past infringements thereof, and Assignee acknowledges receipt of such assignment.


