WHEREAS:

- A. The Assignor is the record owner of US Application No. 78/956,016 for the trademark, **COVET**, in class 3 (the "Mark"), with the United States Patent and Trademark Office;
- B. The Assignee uses the trademark, **COVET**, in commerce in the United States in connection with fragrance products, among other goods in class 3;
- C. The Assignor desires to assign to the Assignee, and the Assignee desires to accept from the Assignor all right, title, and interest in and to the Mark, together with the goodwill of the business, and all common law rights, associated with the Mark;

NOW THEREFORE THIS AGREEMENT WITNESSES that in consideration of the mutual covenants contained in this Agreement and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties, the parties hereby agree as follows:

1. The Assignor hereby assigns, transfers, and conveys to the Assignee all right, title, and interest in and to the Mark, together with (1) the goodwill of the business with which the Mark is associated in the United States; (2) any and all common law rights, title, and interest associated with the Mark in the United States; and (3) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Mark.

- 2. The Assignor further agrees to perform such other lawful acts and to execute such confirmatory assignments and other legal documents as the Assignee, or its counsel, may from time to time reasonably request to effect fully this Assignment and to permit the Assignee to be duly recorded as the owner of the rights hereby conveyed.
