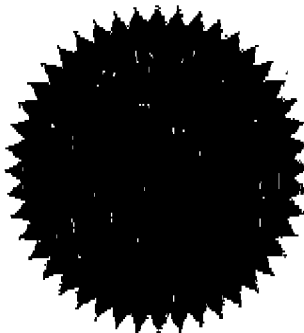

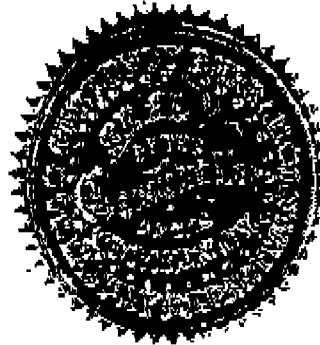
Branch authorizations previously granted to the merging banks automatically convey to the resulting bank and will not be reissued. Please furnish a copy of this certificate to personnel responsible for branch administration.

The OCC also authorizes the resulting bank, should the merger occur between Call Report dates, to recalculate its legal lending limit. The new lending limit should be calculated by using data from the last Call Report of the individual banks filed prior to consummating the merger, as adjusted for the combination. The resulting bank will then file a new Call Report and begin calculating its legal lending limit according to 12 C.F.R. 32.4(a) at the end of the quarter following consummation of the merger.

Dear Mr. Bielawa:

Please be advised that on this date, the Office of the Comptroller of the Currency (OCC) has agreed to grant the request by JPMorgan Chase Bank, National Association ("JPMCB") that it be assigned the historic charter number of the former Bank One, National Association, Chicago, Illinois.

On November 13, 2004, JPMCB converted from a state to a national charter. At that time, the OCC assigned the charter number of 24542 to JPMCB.

Subsequently, on November 13, 2004, Bank One, National Association, Chicago, Illinois, Charter Number 8, and, Bank One, National Association, Columbus, Ohio, Charter Number 7621, merged into and under the charter and title of JPMCB.

The resulting bank, JPMorgan Chase Bank, National Association, New York, New York, Charter Number 24542, elected to retain the main office site of Bank One, National Association, Columbus, Ohio, Charter Number 7621, as the main office of the resulting bank.

This confirms that as of today, the OCC has altered the records for JPMCB by deleting 24542 and assigning the numeral 8 as the ongoing charter number for JPMCB.
