## RECORDAL TRADEMARK LICENSE AGREEMENT

This License Agreement (the "Agreement") is entered into as of December 17, 2010 ("Effective Date"), by and between **The Treadstone Group, Inc.**, with an address at 3272 Lakeshore Road South, Denver, North Carolina ("Licensor") and **Deft, Inc.**, with an address at 17451 Von Karman Avenue, Irvine, California 92614 ("Licensee").

### RECITALS

A. Whereas, Licensor owns all right, title and interest in and to the trademark **WOOD BRILLIANCE** (the "Mark"), including U.S. Trademark Registration No. 3,166,126 (the "Registration") for use in connection with "finishes and coatings, namely interior wood stains and finishes"; and

B. Whereas, Licensee wishes to be granted by Licensor a license to use the Mark as set forth more fully in an Agreement dated December 17, 2010 (the "Agreement"), and Licensor is willing to grant such license;

NOW, THEREFORE, in consideration of the mutual covenants and undertakings set forth herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows.

### LICENSE

Licensor hereby grants to Licensee, its successors and assigns, a royalty-free license to use the exact Mark, in connection with the goods listed in the Registration, as set forth more fully in the Agreement.

This document is for the purpose of recordation only and does not set forth all the rights and obligations of Licensee and Licensor. In the event of a conflict, the Agreement controls.

Licensee acknowledges that the Mark is the exclusive property of Licensor and that Licensor has and retains all intellectual property and other proprietary rights therein. Any use of the Mark by Licensee shall inure to the benefit of Licensor.

IN WITNESS WHEREOF, the parties have caused this Agreement to be duly executed by their authorized representatives effective as of the date first set forth above.
