## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of December 31, 2012, by LA-CO INDUSTRIES, INC., an Illinois corporation (the "Grantor"), in favor of JPMORGAN CHASE BANK, N.A., a national banking association (the "Bank").

### WITNESSETH:

WHEREAS, the Grantor has entered into that certain Credit Agreement dated as of December 31, 2012 (as amended, restated, supplemented or otherwise modified from time to time and in effect, the "Credit Agreement") with the Bank, pursuant to which the Bank has agreed to make certain loans to the Grantor (collectively, the "Loans").

WHEREAS, a condition precedent to the extension of the Loans to the Borrower is the Grantor's execution and delivery of this Agreement.

NOW, THEREFORE, in consideration of the premises and to induce the Bank to enter into the Credit Agreement, and for other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Bank, a continuing security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired:


1. each trademark and trademark application, including, without limitation, each trademark and trademark application referred to in Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof and all goodwill associated therewith;
2. each trademark license, including, without limitation, each trademark license listed on Schedule 1 annexed hereto, together with all goodwill associated therewith; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any trademark, including, without limitation, any trademark referred to in Schedule 1 annexed hereto, any trademark issued pursuant to a trademark application referred to in Schedule 1 and any trademark licensed under any trademark license listed on Schedule 1 annexed hereto (items 1 through 3 being herein collectively referred to as the "Trademark Collateral").

This security interest is granted in conjunction with the security interests granted to the Bank pursuant to the Credit Agreement, the Loan Documents executed in connection therewith and subject to limitations set forth therein. The Grantor hereby acknowledges and affirms that the rights and remedies of the Bank with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Credit Agreement and the Loan Documents, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.





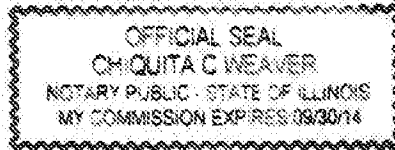
