RELEASE AND REASSIGNMENT OF CERTAIN
TRADEMARKS AS SECURITY

WHEREAS, VSI Corporation, a Delaware corporation (the "Company"), owns the trademarks described in the attached Schedule A (the "Marks") for which there are recordings in the United States Patent and Trademark Office under the numbers set forth in the attached Schedule A; and

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 18, 1989 (the "Agreement") the Company granted a security interest in, among other things, the Marks to secure the payment and performance by the Company of certain of its obligations; and

WHEREAS, the Agreement was recorded in the Assignment Branch, United States Patent and Trademark Office, on August 28, 1989, located on Reel 567, Frame 215-243 and on December 20, 1989, located on Reel 583, Frame 610-630 and an Assignment dated as of February 22, 1995 with respect to the Agreement was executed in favor of the Administrative Agent and was subsequently recorded in the Assignment Branch, United States Patent and Trademark Office on _____, 1995 located on Reel _____, Frame _____.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent does hereby terminate its security interest in, and reassign and reconvey to the Company, the Marks and (a) all renewals thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements or dilutions thereof, (c) the right to sue for past, present and future infringements and dilutions thereof, (d) to the extent permitted by law, all of the Company's rights corresponding thereto throughout the world and (e) the goodwill of the Company's business connected with and symbolized by the Marks.
