TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS**, dated as of November 22, 2013 ("Release"), is made by U.S. BANK NATIONAL ASSOCIATION, as collateral agent ("Collateral Agent") for certain note holders, in favor of Curves International, Inc., a Texas corporation (the "Grantor").

WHEREAS, pursuant to a Second Lien Pledge and Security Agreement, dated as of July 31, 2012 (the "Security Agreement"), by and among Grantor, the other parties thereto and U.S. Bank National Association, as collateral agent, and pursuant to the Grant of Security Interest in Trademarks (the "Trademark Security Agreement"), executed by Grantor in favor of Collateral Agent, Grantor has granted to Collateral Agent a lien on and security interest in and to all right, title and interest in certain trademarks of Grantor described therein (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on August 2, 2012 at Reel 4834, Frame 0665; and

WHEREAS, Collateral Agent now desires to terminate, release and discharge the entirety of its lien on and security interest in and to all right, title and interest in the Trademark Collateral.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement.

SECTION 2. Termination and Release. The Collateral Agent hereby terminates, releases, and discharges its lien on and security interest in and to all right, title and interests in the Trademark Collateral, including, without limitation, the Trademarks of the Grantor listed in Schedule A attached hereto; all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing; terminates the Trademark Security Agreement; and authorizes the recordation of this Release with the USPTO.
