ASSIGNMENT

THIS ASSIGNMENT is made the 17 day of December 2013

BETWEEN:

1. Coty US LLC, a US (Delaware) corporation whose principal place of business is at 2 Park Avenue, New York, 10016 United States of America (the "Assignor");
and
2. LRC Products Limited, a UK corporation and wholly owned subsidiary of Reckitt Benckiser Group Plc, whose principal place of business is at 103-105 Bath Road, Slough, Berkshire SL1 3UH, United Kingdom (the "Assignee")

WHEREAS:

- A. The Assignor is the registered proprietor of US Trade Mark Registration No. 3588815 PEDI-PERFECT, details of which are attached in the schedule to this Assignment (the "Trade Mark").
- B. The parties have agreed to assign the Trade Mark on the following terms:

AGREED TERMS:

1. In consideration of the sum of One Dollar (\$1.00) paid by the Assignee to the Assignor (the receipt of which the Assignor acknowledges) the Assignor assigns to the Assignee all, right, title and interest in and to the Trade Mark together with the goodwill attaching to the Trade Mark. The assignment of the Trade Mark is made on an "as is" basis and the Assignor makes no representations, warranties or covenants in connection with this assignment.
2. The Assignor will at the request of the Assignee execute and sign all such instruments, applications and documents and do all such other acts and

things as may reasonably be required by the Assignee to ensure that the Trade Mark is transferred to the Assignee.

3. The Assignor has the right to sell off and authorize the distribution (but not manufacture or produce) of its remaining stocks of the products marked with the PEDI-PERFECT Trade Mark.
4. This assignment is governed by and is to be construed in accordance with the laws of the State of New York and the parties submit to the exclusive jurisdiction of the federal and state courts located in the State of New York.
