**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of December 31, 2013 (this "Release"), is made by U.S. Bank National Association, as Collateral Agent ("Agent"), in favor of Physiotherapy-BMHI Holdings, Inc. ("Debtor") as follows:

WITNESSETH

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated July 31, 2013 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on July 31, 2013 at Reel/Frame No. 5082/0726, the Debtor granted the Agent a security interest in certain collateral pledged by the Debtor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at the Debtor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

Agent agrees to provide Debtor with any information and additional authorization and documentation necessary to effect the release of Agent's security interest in the Trademark Collateral (without recourse, representation or warranty and at Debtor's sole cost and expense).
