## ASSIGNMENT OF TRADEMARKS

WHEREAS, Parfums de Coeur, Ltd., a Connecticut corporation, with offices at 6 High Ridge Park, Floor C2, Stamford, CT 06905 ("Assignor"), is the owner of the trademark A LITTLE MAGIC, which is the subject of United States Patent & Trademark Office Registration No. 4,423,000, common law rights, and goodwill (the "Mark");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably assigns, transfers, and conveys to Assignee, and Assignee hereby accepts:

All right, title, and interest in and to the Mark worldwide (including, without limitation, all applications and registrations resulting therefrom and all renewals and extensions thereof), together with the worldwide goodwill of the business associated with or symbolized by the Mark, including all common law, goodwill, statutory, and other rights owned by Assignor in the Mark, including, without limitation, designs or logos incorporating the mark or used in association with the mark, and publications including the mark, with the right to recover for damages and profits and all other remedies for past infringements thereof, to have and to hold for Assignee's own use and benefit and the benefit of Assignee's successors, assigns, or legal representatives.


