TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of June 7, 2016, by PACIFIC WESTERN BANK (“Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, EvolveIP, LLC, a Delaware limited liability company (the “Grantor”) and Agent are parties to that certain Trademark Security Agreement dated as of May 12, 2014 (the “Security Agreement”) pursuant to which the Grantor granted a security interest to Agent in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on May 12, 2014, at Reel 5278, Frame 0595;

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “Trademark Collateral”):

(i) all of its Trademarks and all Trademark licenses included in the Collateral, including, without limitation, those referred to on Schedule 1 hereto;

(ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby releases, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in and to the Trademarks and the Trademark Collateral, and hereby grants and conveys to Grantor any and all of Agent’s right, title and interest in and to the Trademarks and the Trademark Collateral in order to revest in Grantor full and unencumbered title to said Trademarks and Trademark Collateral
