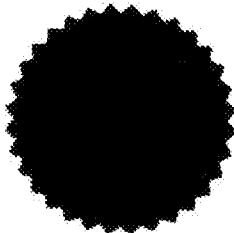

THIRD: The surviving limited liability company is Coty US LLC.


