**AMENDMENT NO. 2 TO
TRADEMARK SECURITY AGREEMENT**

This Amendment No. 2 to the Trademark Security Agreement (the "Amendment"), dated November 7, 2016 (the "Effective Date") is between PlayMonster LLC, a Delaware limited liability company (f/k/a Patch Products, LLC) ("Debtor"), and Balance Point Capital Partners, L.P., a Delaware limited partnership ("Lender" and together with Debtor, the "Parties," and each, a "Party").

WHEREAS, the Parties entered into that certain Security Agreement dated September 10, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") securing Debtor's intellectual property as Collateral to the Lender;

WHEREAS, in furtherance and as confirmation of the security interest granted by Debtor to the Lender under the Security Agreement, and as further security for the payment or performance in full of the Obligations, the Parties entered into a Trademark Security Agreement, dated September 10, 2014 (as the same may be amended, amended and restated, supplemented or otherwise modified from time to time in accordance with its provisions, the "Trademark Security Agreement");

WHEREAS, pursuant to Section 6 of the Trademark Security Agreement, the Parties desire to amend Schedule A of the Trademark Security Agreement; and

WHEREAS, pursuant to Section 9 of the Trademark Security Agreement, the Parties are amending Schedule A of the Trademark Security Agreement.

NOW THEREFORE, in consideration of the mutual promises, covenants and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Definitions. Capitalized terms used and not defined in this Amendment have the respective meanings assigned to them in the Security Agreement or Trademark Security Agreement.

2. Amendments to the Existing Agreement. Schedule A to the Trademark Security Agreement is hereby amended to incorporate all of the trademarks and trademark applications disclosed on Schedule A attached hereto.


3. Date of Effectiveness; Limited Effect. This Amendment will become effective as of the Effective Date. Subject to the Security Agreement and the Trademark Security Agreement, all other terms and conditions of the Security Agreement and Trademark Security Agreement shall remain unmodified and in full force and effect. Without limiting the generality of the foregoing, the amendments contained herein will not be construed as an amendment to or waiver of any other provision of the Security Agreement or Trademark Security Agreement or as

a waiver of or consent to any further or future action on the part of either Party that would require the waiver or consent of the other Party.
