RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is made as of September 13, 2017, by **PACIFIC WESTERN BANK** (as successor in interest by merger to Square 1 Bank) (the "Lender") in favor of **NINESIGMA, INC.**, a Ohio corporation (the "Company") with its principal place of business located at 23611 Chagrin Blvd., Suite 320. Cleveland, OH 44122.

Recitals

WHEREAS, Company entered into that certain Loan and Security Agreement (the "Loan Agreement"), dated as of April 7, 2014, by and between Lender and Company (unless otherwise defined, capitalized terms used herein shall have the meaning assigned in the Loan Agreement);

WHEREAS, pursuant to the terms of the Loan Agreement, Company granted to Lender a security interest in its intellectual property, including without limitation its Patents and Trademarks described on Exhibits A and B attached hereto, (such intellectual property, collectively, the "Intellectual Property Collateral") under an Amended and Restated Intellectual Property Security Agreement dated as of May 31, 2017 (the "IP Security Agreement"), and recorded with the US Patent and Trademark Office as set forth on Exhibits A and B.

WHEREAS, Company has no outstanding obligations to Lender under the terms of the IP Security Agreement, Lender agrees to release its security interest in the Intellectual Property Collateral.


Agreement

Now therefore, Lender hereby terminates, discharges, and releases its security interest, liens, and all other rights it may have, if any, in the Intellectual Property Collateral, including without limitation the Patents and Trademarks described on Exhibits A and B, and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds infringement suits), all rights corresponding thereto throughout the world and all reissues, divisions, continuations, renewals, extensions, and continuations-in-part thereto, and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property Collateral. Lender authorizes and requests that the Commissioner for Patents, the Commissioner for Trademarks, and any other applicable government officer or relevant governmental authority record this Release.
