**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the “Release”) is dated as of December 22, 2017 by U.S. BANK NATIONAL ASSOCIATION, as collateral agent (together with its successors and permitted assigns in such capacity, the “Collateral Agent”) for the benefit of the Secured Parties (as defined in the Collateral Agreement (as defined below)) in favor of PHWLTV, LLC, a Nevada limited liability company (“PHWLTV”), JAZZ CASINO COMPANY, L.L.C., a Louisiana limited liability company (“Jazz Casino Company”), 3535 LV NEWCO, LLC, a Delaware limited liability company (“3535 LV NewCo”), and PARBALL NEWCO, LLC, a Delaware limited liability company (“Parball NewCo”) (each a “Pledgor” and collectively, the “Pledgors”).

WITNESSETH

WHEREAS, Caesars Growth Properties Holdings, LLC (“CGPH”) and Caesars Growth Properties Finance, Inc. (together with CGPH, the “Issuers”), and each subsidiary of the Issuers identified in the Collateral Agreement and the Collateral Agent entered into that certain Collateral Agreement (Second Lien) dated as of May 20, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, (i) PHWLTV executed and delivered to the Collateral Agent that certain Trademark Security Agreement (Second Lien) dated as of May 20, 2014 (the “PHWLTV Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office (“USPTO”) on June 6, 2014 at Reel/Frame No. 5298/0234, (ii) Jazz Casino Company executed and delivered to the Collateral Agent that certain Trademark Security Agreement (Second Lien) dated as of May 20, 2014 (the “Jazz Casino Company Trademark Security Agreement”) and recorded with the USPTO on June 6, 2014 at Reel/Frame No. 5298/0256, (iii) 3535 LV NewCo executed and delivered to the Collateral Agent that certain Trademark Security Agreement (Second Lien) dated as of May 20, 2014 (the “3535 LV NewCo May 2014 Security Agreement”) and recorded with the USPTO on June 6, 2014 at Reel/Frame No. 5298/0388, (iv) Parball NewCo executed and delivered to the Collateral Agent that certain Trademark Security Agreement (Second Lien) dated as of May 20, 2014 (the “Parball NewCo Trademark Security Agreement”) and recorded with the USPTO on June 6, 2014 at Reel/Frame No. 5298/0421 and (v) 3535 LV NewCo executed and delivered to the Collateral Agent that certain Trademark Security Agreement (Second Lien) dated as of August 26, 2014 (the “3535 LV NewCo August 2014 Trademark Security Agreement”) and collectively with the PHWLTV Trademark Security Agreement, the Jazz Casino Company Trademark Security Agreement, the 3535 LV NewCo May 2014 Trademark Security Agreement and the Parball NewCo Trademark Security Agreement, the “Trademark Security Agreements”) and recorded with the USPTO on August 27, 2014 at Reel/Frame No. 5352/0238, pursuant to which the Pledgors granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of the Pledgors’ right, title and interest in or to any and all of the IP Collateral (as defined in the Trademark Security Agreements); and

WHEREAS, the Pledgors have requested that the Agent release its security interest in all right, title and interest in or to any and all of the IP Collateral in connection with the discharge on the date hereof of the Indenture, dated as of April 17, 2014, between Caesars Growth Properties Holdings, LLC, Caesars Growth Properties Finance, Inc. and U.S. Bank National Association.


NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in or to any and all of the IP Collateral, including the trademark registrations and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the IP Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgors,

without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the IP Collateral under the Collateral Agreement and the Trademark Security Agreements.
