DECLARATION FOR CORRECTION OF OWNERSHIP


I, Robert P. Felber, Jr., declare as follows:

1. I am legal counsel for CFN Holding Co., a Delaware corporation with offices at 2003 Western Avenue, Suite 203, Seattle, Washington 98121 (“CFN”). CFN is the owner of United States Registration No. 1574809 for the service mark CFN COMMERCIAL FUELING NETWORK (and design) (the “Registration”).
2. I am submitting this declaration for the purpose of correcting the assignment records of the U.S. Patent and Trademark Office (the “USPTO”) with respect to the Registration.
3. On April 22, 2004, Commercial Fueling Network, Inc., the then owner of the Registration, assigned its entire interest in the Registration to CFN Holding Company. This assignment was recorded with the USPTO at Reel/Frame 2833/0616 (the “Assignment”).
4. When the Assignment was recorded, the assignee was mistakenly identified by name as CFN Holding Company when, in fact, the correct name of the assignee was CFN Holding Co. (as depicted in the Intellectual Property Assignment recorded with the USPTO).
6. CFN Holding Company, is not now, and was not at the time of the Assignment, a Delaware corporation. Only CFN Holding Co. existed as a Delaware corporation at the time the Assignment was executed and recorded.
7. Based on the foregoing, I respectfully request that the USPTO correct the assignment records of the USPTO with respect to the Registration to: (a) identify the assignee in the

Assignment as CFN Holding Co.; and (b) otherwise correct the records of the USPTO to identify the owner of the Registration as CFN Holding Co.

8. I hereby declare that all statements made herein of my own knowledge are true and correct.

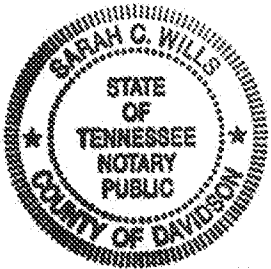
