RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is made as of March 9, 2018 by **PACIFIC WESTERN BANK** ("Lender") in favor of **FORMSTACK, LLC**, an Indiana limited liability company ("Company") with its principal place of business located at 8604 Allisonville Rd, Suite 300, Indianapolis, IN 46250.

Recitals

WHEREAS Company granted to Lender a security interest in its copyrights, patents and trademarks, including without limitation its trademarks described on Exhibit A attached hereto, (collectively, the "Intellectual Property Collateral") under an Intellectual Property Security Agreement dated as of October 7, 2015 (the "Security Agreement"), and recorded with the US Patent and Trademark Office on October 20, 2015 at Reel and Frame Number 5648/0436; and

WHEREAS Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to terminate and release the entirety of its security interest in the Intellectual Property Collateral.

Agreement

Now therefore, for good and valuable consideration, including the satisfaction of all obligations secured by the Intellectual Property Collateral pursuant to the Security Agreement, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates, cancels, releases and discharges any and all security interests in, and claims against, the Intellectual Property Collateral, and any right, title or interest of Lender in and to such Intellectual Property Collateral shall hereby cease and become void.

Lender hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office and any other applicable government officials to record this Release.


Lender and Company hereby agree that this Release may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page of this Release by facsimile or email shall be as effective as if the original signature had been delivered to the other party.
