## TRADEMARK SECURITY AGREEMENT SUPPLEMENT

This **TRADEMARK SECURITY AGREEMENT SUPPLEMENT** (this "Trademark Security Agreement Supplement") dated April 9, 2018, is made by the Person listed on the signature page hereof (the "Grantor") in favor of DEUTSCHE BANK TRUST COMPANY AMERICAS, as collateral agent (the "Collateral Agent") for the Secured Parties (as defined in the Security Agreement referred to below).

Reference is made to the Collateral Agreement dated as of October 17, 2017 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), among Scientific Games International, Inc., a Delaware corporation (the "Issuer"), Scientific Games Corporation, a Nevada corporation ("Holdings"), the subsidiaries of Holdings party thereto and the Collateral Agent. Pursuant to that certain Indenture dated as of October 17, 2017 (as amended, supplemented or otherwise modified from time to time, the "Indenture") among the Issuer, Holdings, the Guarantors from time to time party thereto (each of the foregoing including the Issuer and Holdings individually a "Grantor," and, collectively, the "Grantors"), and Deutsche Bank Trust Company Americas, a New York banking corporation, as trustee (the "Trustee") and collateral agent, the Issuer has issued \$1,250,000,000 aggregate principal amount of 5.000% Senior Secured Notes due 2025 (together with any Additional Securities issued under the Indenture, the "Notes"). Each Grantor will receive substantial benefits from the issuance of the Notes pursuant to the Indenture.

WHEREAS, pursuant to the Indenture, the Grantors have executed and delivered or otherwise become bound by the Security Agreement and that certain Trademark Security Agreement dated December 14, 2017 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement").

WHEREAS, under the terms of the Security Agreement, each Grantor has agreed to grant to the Collateral Agent, for the benefit of the Secured Parties, a security interest in any after-acquired intellectual property collateral of such Grantor and has agreed in connection therewith to execute this Trademark Security Agreement Supplement for recording with the United States Patent and Trademark Office.

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement or the Trademark Security Agreement, as applicable. The rules of construction specified in Section 1.2 of the Security Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the Obligations, each Grantor, pursuant to the Security Agreement, did and hereby does grant to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Additional Trademark Collateral"):


(i) all trademarks, trade names, corporate names, company names, business names, domain names, fictitious business names, trade dress, trade styles, service marks, logos and other source or business identifiers, designs and general intangibles of like nature, and all goodwill associated therewith or symbolized thereby, all registrations and recordings thereof, and all applications in connection therewith (except for "intent to use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or 1(d) of said Act has been

filed), whether in the United States Patent and Trademark Office or in any similar office or agency of the United States or any State thereof, and all United States common-law rights related thereto owned by such Grantor in its own name, including, without limitation, any of the foregoing referred to in Schedule I and (ii) the right to obtain all renewals thereof.


SECTION 3. Security Agreement. The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights, remedies, protections and immunities of the Collateral Agent with respect to the Trademark Collateral and actions taken in connection therewith are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern. Schedule I to the Trademark Security Agreement is, effective as of the date hereof, hereby supplemented to add to such Schedule the Additional Trademark Collateral.


