## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 19, 2020, is from U.S. Bank National Association, in its capacity as Collateral Agent (the "Collateral Agent") to FTS International Services, LLC (the "Grantor").

### **WITNESSETH:**

WHEREAS, pursuant to that certain Security Agreement dated as of April 16, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Grantor granted a security interest to the Collateral Agent in certain collateral;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of April 16, 2014, by and between the Collateral Agent and the Grantor (the "Trademark Security Agreement"), the Grantor, by reference to the Security Agreement, reaffirmed its intent to grant a security interest to the Collateral Agent in the Grantor's registered or applied for trademarks, trade names and service marks, including the trademarks listed in Schedule I hereto (collectively, the "Released Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 17, 2014 at Reel 5262, Frame 0761;

WHEREAS, on November 4, 2020, an order was entered confirming the Grantor's Joint Prepackaged Chapter 11 Plan of Reorganization (including all exhibits thereto, as further amended, modified or supplemented from time to time, the "Plan");

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its security interest in the Released Collateral in connection with and pursuant to the Plan;

NOW, THEREFORE, in consideration of the foregoing, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth herein, the Collateral Agent hereby states as follows:

1. Definitions. Capitalized terms used herein and not otherwise defined have the meanings specified in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release of Security Interest. The Collateral Agent hereby (i) terminates, cancels, releases, and discharges, without recourse, representation, or warranty, any and all security interest it has in or to the Released Collateral, including under the Security Agreement and the Trademark Security Agreement, and (ii) reassigns any and all such right, title, and interest (if any) that the Collateral Agent may have in the Released Collateral to the Grantor. Any right, title, or interest of the Collateral Agent in such Released Collateral shall hereby cease and become void.

3. Further Assurances. The Collateral Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by the Grantor to effect the termination and release of the security interest contemplated hereby.
