RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of January 28, 2021 by U.S. BANK NATIONAL ASSOCIATION, as collateral agent (in such capacity, the “Collateral Agent”) for the Noteholders, in favor of VECTOR TOBACCO INC. (the “Grantor”). All capitalized terms used but not defined herein have the meanings assigned to them (including by reference) in the Security Agreement (as defined below).

WHEREAS, the Grantor and the Collateral Agent are party to (i) that certain Security Agreement dated as of January 27, 2017 (as amended, supplemented, replaced or otherwise modified from time to time, the “Security Agreement”) and (ii) that certain Trademark Security and Pledge Agreement, dated as of January 27, 2017 (the “Trademark Security Agreement”), pursuant to which the Grantor granted to the Collateral Agent for the benefit of the Secured Parties, a security interest in and lien on all of the Grantor’s right, title and interest in all Trademarks, Trademark Licenses and Trade Secret Licenses, including those referred to on Schedule A hereto (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 15, 2017 at Reel/Frame 5991/0265; and

WHEREAS, the Grantor has requested that the Collateral Agent execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral for filing and recordation with the United States Patent and Trademark Office.


