This deed is dated 11 February 2022 (the Effective Date)

Parties

- (1) **DAVID BECKHAM** c/o Harbottle & Lewis LLP of 7 Savoy Court, London WC2R 0EX (**Assignor**)
- (2) **DB VENTURES LIMITED**, a company incorporated in England and Wales under registered number 09178135 whose registered office is at 7 Savoy Court, London WC2R 0EX (**Assignee**)

BACKGROUND

- (A) The Assignor is the owner of the Assigned Rights (as defined below).
- (B) The Assignor has agreed to assign the Assigned Rights to the Assignee on the terms set out in this Deed.

Agreed terms

1. Interpretation

The following definitions and rules of interpretation apply in this Deed.

1.1 Definitions:

Assigned Rights	means the Trade Marks;
Business	has the meaning given in the Shareholders' Agreement;
Business Day	means a day (other than a Saturday or Sunday) on which banks in the City of London and New York are open for ordinary banking business;
Completion	has the meaning given in the SPA;
Copyright Assignment	has the meaning given in the SPA;
DB Characteristics	has the meaning given in the Shareholders' Agreement;
Domain Name Assignment	has the meaning given in the SPA;
General Rights Assignment	has the meaning given in the SPA;
Holdings	means DRJB Holdings Limited;
Jointly Owned IP Assignment	Has the meaning given in the SPA;
Personal Services Agreement	has the meaning given in the Shareholders' Agreement;
Trade Marks	means those trade marks listed in Schedule 1 of this Deed, and any other trade mark, service mark, business or brand name, goodwill or style or presentation of goods or services whether or not registered held by the Assignor

which (i) contain (or are comprised wholly or partly of) any of the DB Characteristics or (ii) relate to the Business;

Shareholders' Agreement	means the shareholders' agreement in relation to Holdings to be entered into between ABG-Beckham LLC, Victoria Beckham (VB), the Assignor, Footwork Productions Limited (FWPL) and Holdings at Completion;
SPA	means the share sale and purchase agreement to be entered into on Completion between the Assignor, VB, FWPL, Authentic Brands Group LLC (ABG), Holdings and the Assignee pursuant to which (amongst other things) the Assignor and VB shall sell and ABG shall purchase certain shares in Holdings;
Third Party Rights	has the meaning given in the General Rights Assignment; and
Transaction Documents	has the meaning given in the SPA.

- 1.2 Clause, Schedule and paragraph headings shall not affect the interpretation of this Deed.
- 1.3 A **person** includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).
- 1.4 The Schedules form part of this Deed and shall have effect as if set out in full in the body of this Deed. Any reference to this Deed includes the Schedules.
- 1.5 References to clauses and the Schedule are to the clauses and the Schedule of this Deed unless otherwise stated.
- 1.6 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.7 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.8 This Deed shall be binding on, and enure to the benefit of, the parties to this Deed and their respective personal representatives, successors and permitted assigns, and references to any party shall include that party's personal representatives, successors and permitted assigns.
- 1.9 A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time and shall include all subordinate legislation made from time to time under that statute or statutory provision.
- 1.10 Any words following the terms **including**, **include**, **in particular**, **for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.

1.11 Definitions used but not otherwise defined in this Deed shall have the same meaning as definitions as defined in the General IP Assignment.

2. Assignment

2.1 Subject to the Third Party Rights, the Assignor hereby assigns to the Assignee absolutely with full title guarantee all right, title and interest held by him, or held on his behalf, at Completion in and to the Assigned Rights, including:

- (a) the absolute entitlement to any registered trade marks granted pursuant to any of the applications comprised in the Assigned Rights in any country in the world;
- (b) all rights to claim priority in the Assigned Rights;
- (c) all rights to any extensions, renewals or amendments of or to the Assigned Rights;
- (d) all statutory and common law rights attaching to the Assigned Rights, together with any goodwill owned by the Assignor arising from any past or future use of the Assigned Rights in connection with any business, goods or services; and
- (e) the right to bring, make, oppose, defend and appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership of any of the Assigned Rights, whether occurring before, on or after the date of this Deed.

2.2 To the extent the assignment of the Assigned Rights under Clause 2.1 should fail to take effect for any reason, the Assignor hereby grants to the Assignee an exclusive, worldwide, perpetual, irrevocable, licence to exploit, commercialise and use (and to grant, subject to the terms of the Shareholders' Agreement and the Personal Services Agreement, third parties the right to exploit, commercialise and use) in any manner the Assigned Rights.

3. Further assurance

3.1 At the Assignee's expense the Assignor shall, and shall use reasonable endeavours to procure that any necessary third party shall, promptly, and in any event within 30 days of receipt of a request from the Assignee to do so, execute such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this Deed, including registration of the Assignee as applicant for or registered proprietor of the Assigned Rights.

3.2 The Assignor and the Assignee agree that in the event that there are any Trade Marks which do not appear in Schedule 1, these nevertheless constitute Assigned Rights and each party will do all things required in order to ensure the Assignee obtains the benefit of such Trade Marks and these will be added by the parties to Schedule 1.

3.3 The Assignor hereby appoints the Assignee to be its attorney to execute any instrument and do anything, and generally to use its name, for the purpose of giving the Assignee the full benefit of this Deed. The Assignor acknowledges that a certificate in writing signed by the director or officer of the Assignee stating that an instrument or act falls within the authority conferred by this Deed shall constitute conclusive evidence that such instrument or act falls within the powers granted under this Clause 3. This power of attorney is irrevocable as long as any of the Assignor's

obligations under this Deed remain undischarged. Without prejudice to Clause 3.5 below, the Assignee may acting as the Assignor's attorney pursuant to this Clause, in any way it reasonably thinks fit and in the name and on behalf of the Assignor take any reasonable action that this Deed requires the Assignor to take, if such action has not been taken by the Assignor within 30 days of receipt of a request from the Assignee to do so.

- 3.4 The Assignor shall ratify and confirm everything that the attorney and any substitute attorney lawfully does or arranges using the powers granted under this Clause 3.
- 3.5 The Assignor shall at the cost and request of the Assignee make available for collection by the Assignee (or the Assignee's nominated representative) after the date of this Deed any deeds, documents of title, certificates and other files and records that are held by the Assignor (or its agents) relating to the Assigned Rights.
- 3.6 For the avoidance of doubt, all costs and expenses associated with, arising out of and/or related to the recording of the Assignee as the proprietor of any of the Assigned Rights assigned pursuant to this Deed shall be borne by the Assignee.
- 3.7 The Assignor shall, within 10 days of receipt of a request from the Assignee and at the Assignee's expense, sign such letters of consent as may reasonably be required from time to time for the purposes of enabling the Assignee to file any trade mark applications incorporating the DB Characteristics or to record any prior assignments to DB of the Assigned Rights.

4. Liability

Each party's maximum aggregate liability in respect of any and all claims or demands (whether arising in contract, tort or otherwise) arising under or pursuant to this Deed, the General Rights Assignment, the Copyright Assignment, the Domain Name Assignment and/or the Jointly Owned IP Assignment) shall be limited as set out in clause 6 of the General Rights Assignment.

5. Force Majeure

Neither party shall be in breach of this Deed nor liable for delay in performing, or failure to perform, any of its obligations under this Deed if such delay or failure result from events, circumstances or causes beyond his reasonable control. In such circumstances the time for performance shall be extended by a period equivalent to the period during which performance of the obligation has been delayed or failed to be performed.

6. Waiver

No failure or delay by a party to exercise any right or remedy provided under this Deed or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of any such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

7. Entire agreement

7.1 This Deed and the other Transaction Documents constitute the entire agreement between the parties and supersede and extinguish all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to their respective subject matters.

7.2 Each party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this Deed. Each party agrees that it shall have no claim for innocent or negligent misrepresentation or negligent misstatement based on any statement in this Deed.

8. Variation

No variation of this Deed shall be effective unless it is in writing and signed by the parties (or their authorised representatives).

9. Confidentiality

The parties acknowledge and agree that the provisions of this Deed shall be deemed to be included within the definition of "Confidential Information" included in the Shareholders' Agreement and all corresponding obligations relating to such Confidential Information in the Shareholders' Agreement are hereby incorporated into this Deed *mutatis mutandis*.

10. Severance

10.1 If any provision or part-provision of this Deed is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this Clause shall not affect the validity and enforceability of the rest of this Deed.

10.2 If one party gives notice to the other of the possibility that any provision or part-provision of this Deed is invalid, illegal or unenforceable, the parties shall negotiate in good faith to amend such provision so that, as amended, it is legal, valid and enforceable, and, to the greatest extent possible, achieves the intended commercial result of the original provision.

11. Counterparts

11.1 This Deed may be executed in any number of counterparts, each of which shall constitute a duplicate original, but all the counterparts shall together constitute the one Deed.

11.2 Transmission of an executed counterpart of this Deed by email (in PDF, JPEG or other agreed format) shall take effect as the transmission of an executed "wet-ink" counterpart of this Deed.

12. Third party rights

The Contracts (Rights of Third Parties) Act 1999 shall not apply to this Deed or any of its provisions.

13. Notices

13.1 Any notice or other communication given under this Deed shall be in writing and shall be delivered personally or sent by first class post (or airmail if overseas) or by email, to the party due to receive the notice or communication, at its address or email address set out in Clause 13.2 or such other address or email address which may from time to time be notified by a party to the other parties in writing as being its address or email address for the purposes of notices sent under this Agreement.

13.3 A notice or other communication shall be deemed given:

- (a) if delivered personally, upon delivery at the address referred to in Clause 13.1;
- (b) if sent by first class post (other than airmail), 2 Business Days after the date of posting;
- (c) if sent by airmail, 5 Business Days after the date of posting;
- (d) if sent by email, upon the sending of the email to the correct email address,

provided that where delivery or sending occurs after 18.00 on a Business Day in the place of receipt or on a day which is not a Business Day, receipt shall be deemed to occur at 09.00 in the place of receipt on the next following Business Day.

13.4 In proving the giving of notice, it shall be sufficient to prove that the envelope containing the notice was properly addressed to the relevant party and delivered either to that address or posted as first class post (or registered airmail if overseas) or emailed to the correct email address of the relevant party.

14. Governing law

This Deed and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales.

15. Jurisdiction

15.1 Any dispute or difference arising out of or in connection with this Deed (including any question regarding its existence, validity or termination or any contractual or non-contractual obligations arising from or connected with this Deed or the legal relationships established by this Deed) shall be resolved by arbitration under the rules of the London Court of International Arbitration in force at the date of this Deed, which shall be deemed to be incorporated by reference into this Article. It is agreed that:

- (a) there shall be one arbitrator who shall be appointed by the London Court of International Arbitration;
- (b) the seat and legal place of the arbitration shall be London, England;
- (c) the language of the arbitration shall be English;
- (d) the governing law of the arbitration agreement shall be the laws of England and Wales; and
- (e) any decision of the arbitrator shall be final and binding and complied with by the parties without delay.

This document has been executed as a deed and is delivered and takes effect on the date stated at the beginning of it.




