**RELEASE OF GRANT OF SECURITY INTEREST - - TRADEMARKS**

This **RELEASE OF GRANT OF SECURITY INTEREST - - TRADEMARKS** (the “Release”), is dated as of October 15, 2021, by **BLUE TORCH FINANCE LLC**, as collateral agent (in any such capacity, together with its successors in such capacity, the “Assignee”), in favor of **ENJOY TECHNOLOGY, INC.** (the “Assignor”). Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned to such terms in the Security Agreement (as defined below).

**W I T N E S S E T H**

WHEREAS, pursuant to that certain Assignment for Security– Trademarks, dated as of November 13, 2020 made by the Assignor in favor of the Assignee (the “Security Agreement”), a security interest in all of the Assignor’s right, title and interest in, to and under the Collateral of the Assignor’s, including those identified on Schedule A attached hereto (the “Trademark Security Interest”);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on November 13, 2020 at Reel/ Frame 7105/0884; and

WHEREAS, the Assignor, on behalf of itself and the Secured Parties (as defined in the Financing Agreement), desires to terminate and grant a release of the Trademark Security Interest as provided in this Release.

NOW, THEREFORE, for good and valuable consideration tendered by the Assignor, the receipt and adequacy of which are hereby acknowledged, the Assignee, on behalf of itself and the Secured Parties, does hereby agree as follows:

1. The Assignee, on behalf of itself and the Secured Parties, hereby (a) terminates the Security Agreement, (b) releases, relinquishes, terminates and discharges the Trademark Security Interest in its entirety and (c) reassigns to the Assignor any and all right, title and interest of any nature whatsoever which it may hold in or to the any of the Collateral (including, without limitation, the trademark(s) and/or trademark application(s) identified on Schedule A attached hereto) and associated common law rights and goodwill appurtenant thereto.


2. The Assignee, on behalf of itself and the Secured Parties, authorizes the United States Patent and Trademark Office and any other applicable governmental authority to record this Release.
